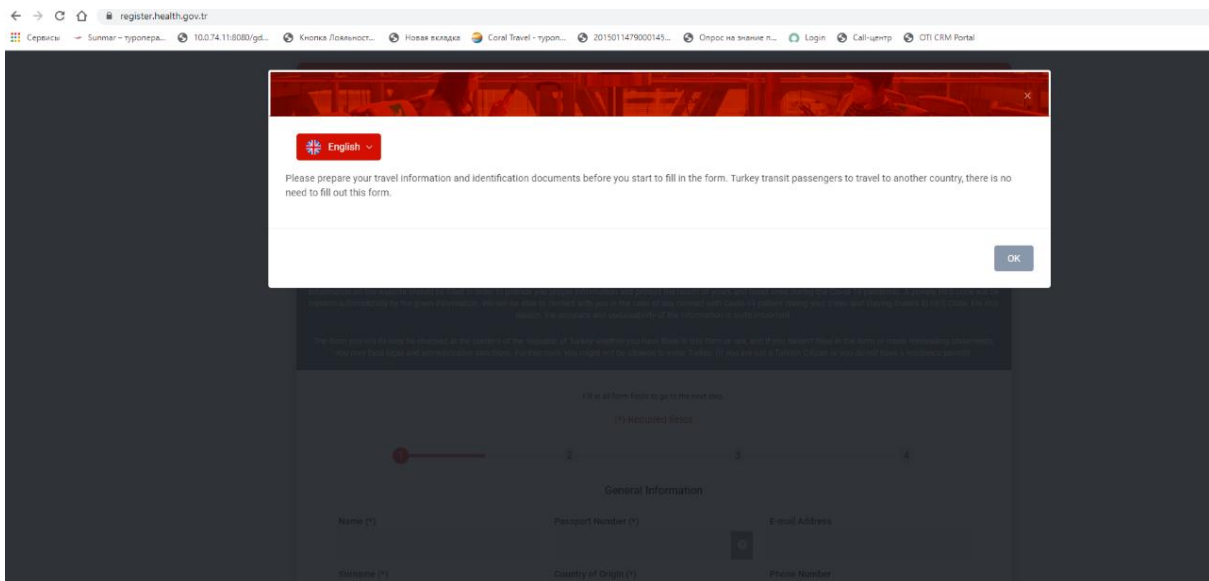
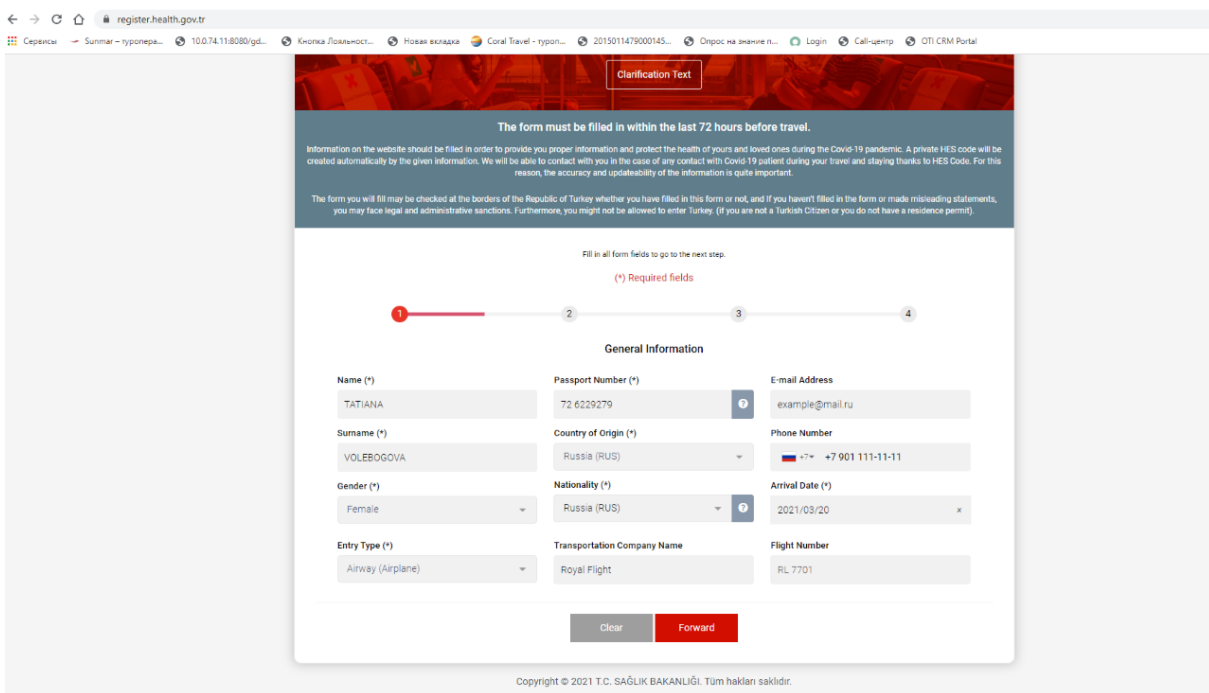


1. При входе, на главной странице можно изменить язык, на котором будет отображаться информация.
